Police Chief Monroe: The Trumbull Cty Prosecutor's office gave Howland Police Dept. an award for investigative excellence for a homicide that occurred in December. Sgt. Jeff Urso, Asst. Chief Roberts, Detective Soroka and Detective Mike Stabile of Warren PD, arresed the suspect that night and he was convicted within 5 months.
