Summary of Meeting:

Tim Shaftner, Director of Children Services: Explained the renewal levy and stated that out of five states, Ohio ranks last in the amount of the state contributes to local child welfare. Children Services depends upon the voters to pass the levy for funding. The cost to homeowner who owns a \$100,000 home would be \$24 per year.

Fire Chief James Pantalone: Safety Day was held at Home Depot Saturday. October is Fire Prevention Month. We will be in the schools with our smoke prevention trailer.

Police Chief Paul Monroe: Last week finished the mobile police academy. Today there was a drug search at the Middle School assisted by the Ohio State Patrol. No drugs were detected.

Public Works Director David McCann: Paving contractor will start milling roads around the end of next week. The Public Works Dept. has started skim paving, but a mechanical problem with the tack truck has set us back. Scrap tire drop off is being conducted and will end October 10th. Administrator Darlene St. George asked David McCann to talk about the salt prices and have the Trustees make a decision on how much to purchase (500 to 600 tons).

Salt: Attended a meeting at the County concerning the salt prices. The summer fill-up was priced at \$42/ton and the winter fill-up price will be \$105/ton. The Township put in a request for 2,250 tons for this season and also have 625 tons left from last season. We have to purchase half in the summer/fall fill-up and the rest in the winter fill-up. The County Engineer is requiring a commitment by Friday for at least ½. Trustees felt it was better to commit to 600 tons so we don't run the risk of running short for the season. Trustees directed David to order 600 tons.
