Summary of Meeting:

Trustee Vansuch: An interested party wants to purchase 120 acres of property located nex to the airstrip on North River Road, west of the creek and north towards Bazetta Township. This property was purchased with Clean Ohio Funds. This property is dedicated and restricted to natural and wildlife wetland use.

Trustee Clark stated that the property was purchased in 2002 and the intent is for the property to stay forever green and could never be developed. This property could never be sold.

Trustee Clark: Mentioned the grant projects implemented in 2014. The total amount of grants is \$2,050,107 that the employees and administration were able to secure and benefit Howland Township. All departments secured various grants. Everyone who worked on the grants needs to be commended as this saved the tax payers dollars for various projects.

The Township is contributing \$8,650 for the fees to participate in the Trumbull Transit Board. That means Township residents only pay \$1.00 per trip. That allows the Township residents who need transportation 8,750 trips at a very inexpensive rate.

Administrator St. George: Proud of everyone who participated in the food pantry drive. The Police and Firefighter's unions each donated \$1,000. This year is the most money ever raised and will help support two food pantries for a year. Firefighter James Williamson organized the drive, and got all the volunteers together. Can't thank everyone enough for helping and how proud I am.
